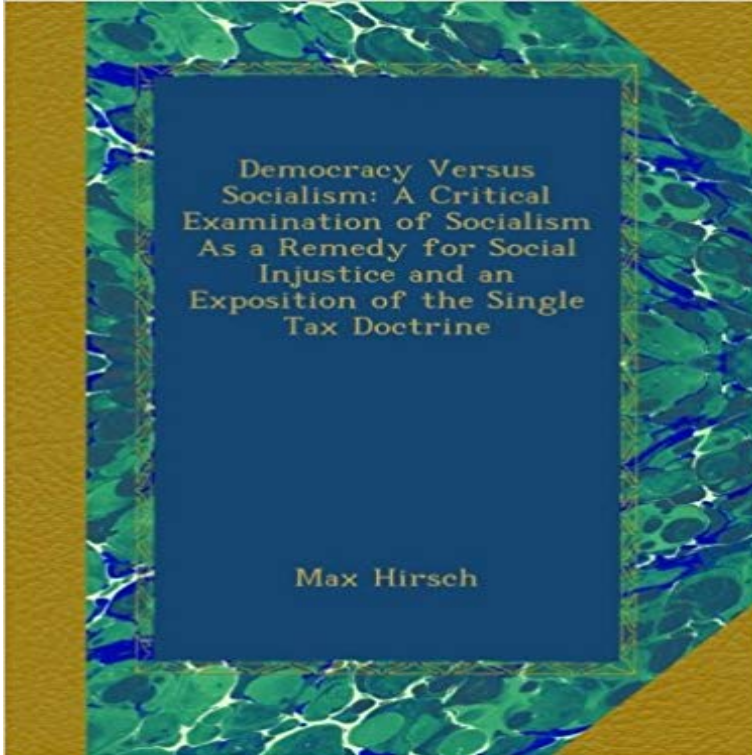


# Democracy Versus Socialism: A Critical Examination of Socialism As a Remedy for Social Injustice and an Exposition of the Single Tax Doctrine
