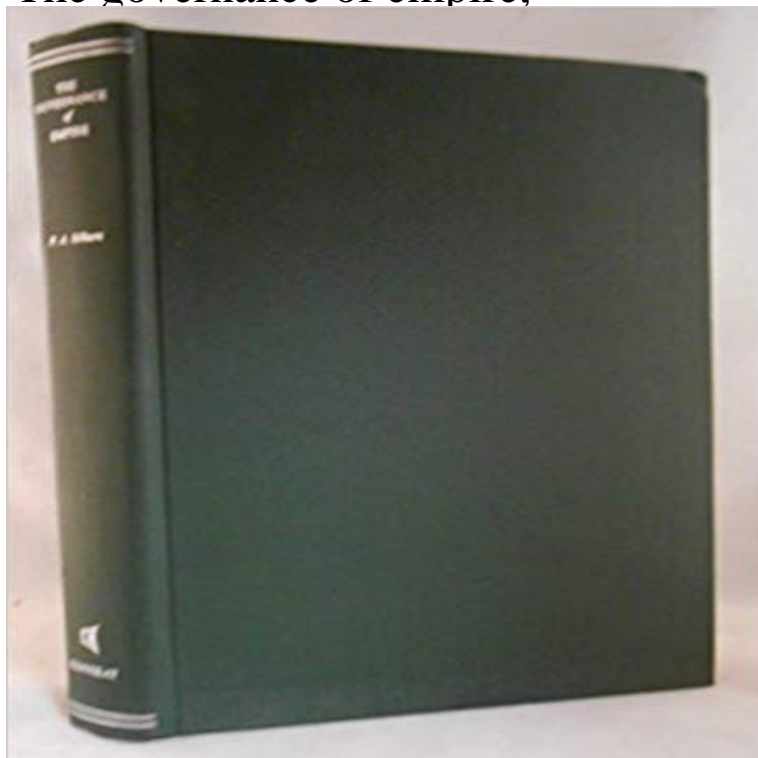


## The governance of empire,
