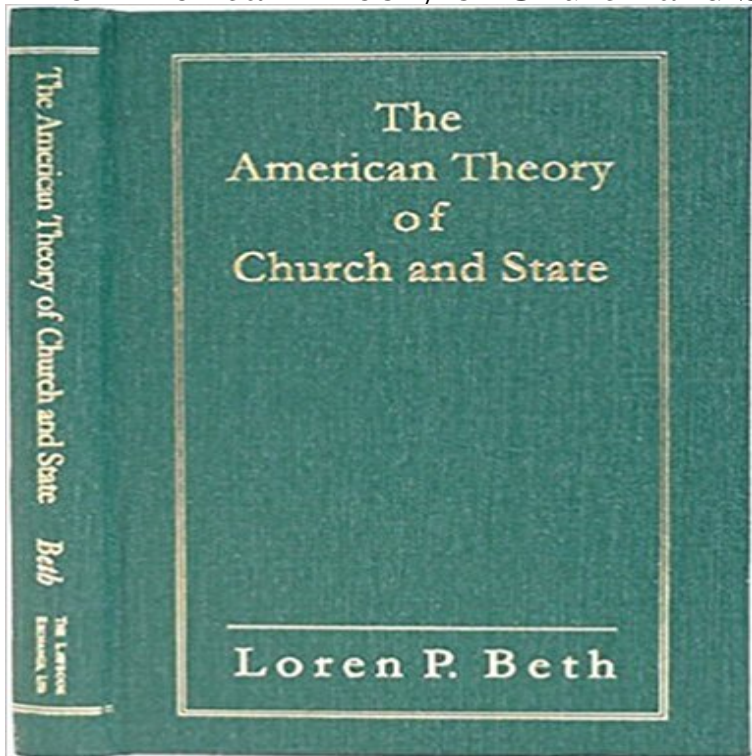


# The American Theory of Church and State
