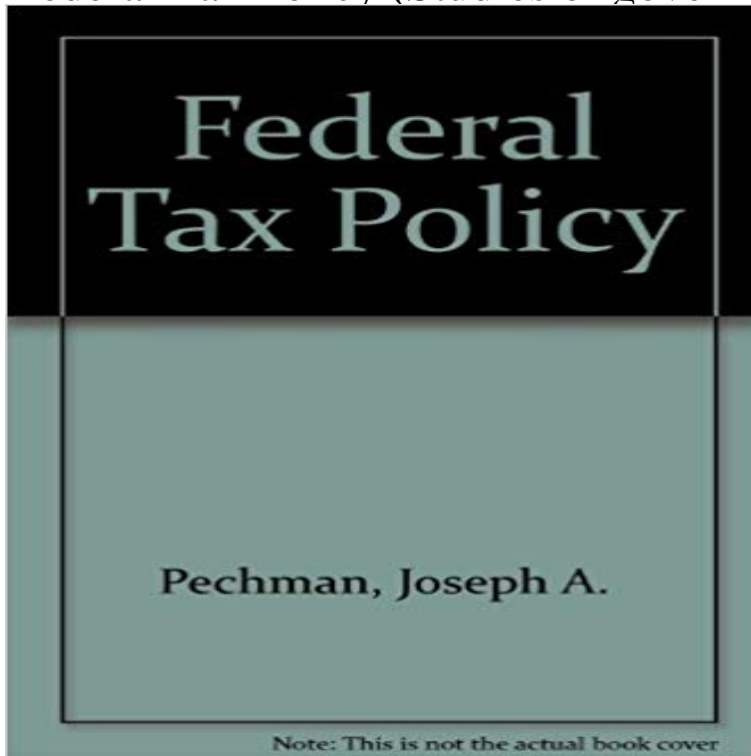


Federal Tax Policy (Studies of government finance : Second series)
