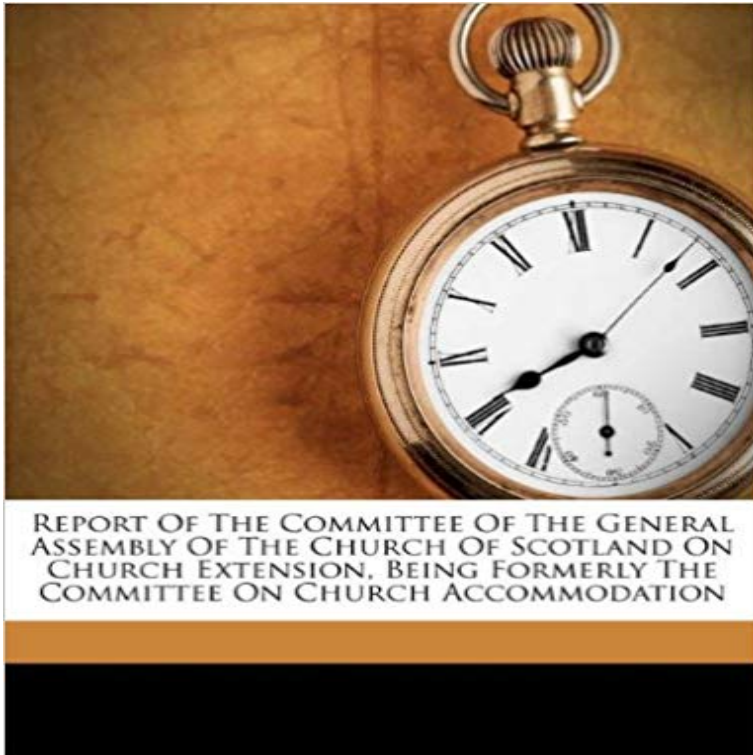


# Report Of The Committee Of The General Assembly Of The Church Of Scotland On Church Extension, Being Formerly The Committee On Church Accommodation
