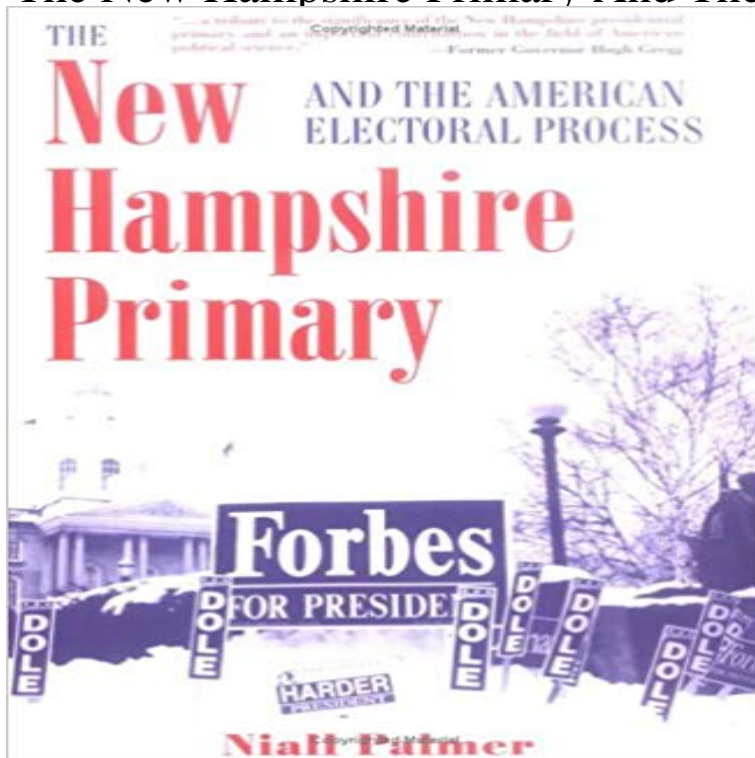


# The New Hampshire Primary And The American Electoral Process
