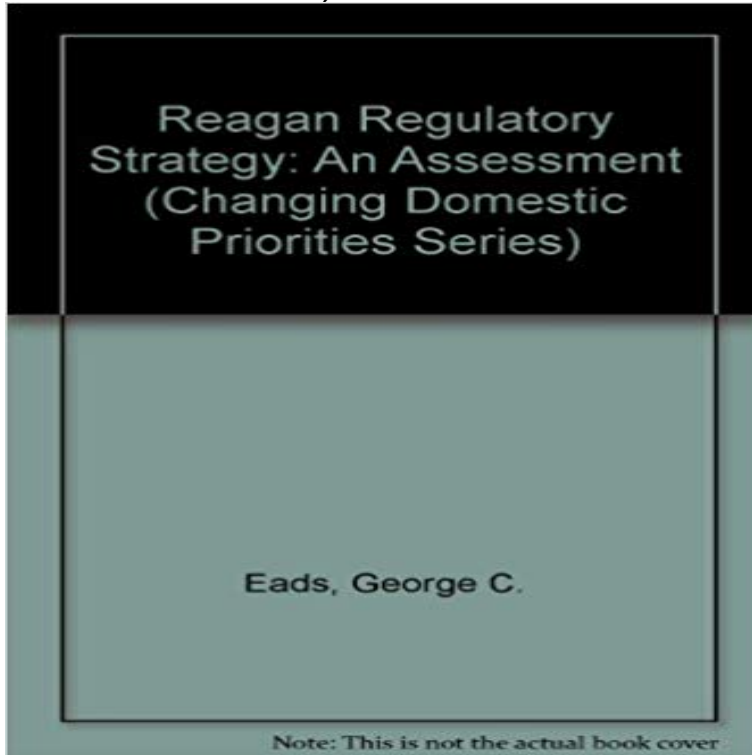


## REAGAN REGULATORY STRATEGY, THE (Changing Domestic Priorities Series)



The Reagan administration assigned regulatory relief a more prominent place in its economic program than had any other recent administration-rivalling that of tax, budgetary, and monetary policy. This book discusses the design of the regulatory strategy in Reagans first term, and its impacts. One of the books most provocative essays is by Murray Weidenbaum, a chairman of the Council of Economic Advisers under Reagan. It is a remarkably candid account of the origins of the strategy and its immediate results.
