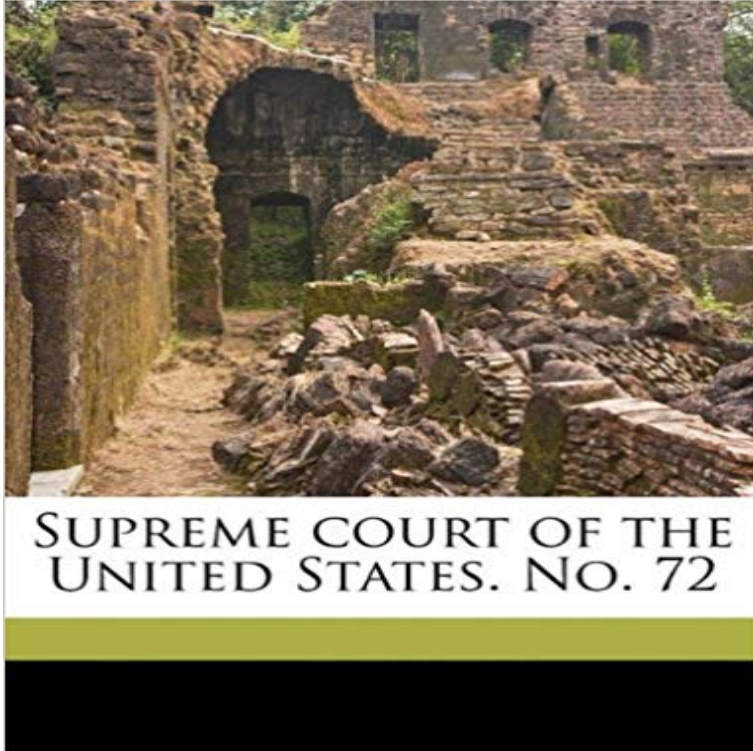


## Supreme court of the United States. No. 72
